

## **Participant Agreement and Waiver – Team Captain**

**Team Captain Responsibilities:** Team Captains are hereby responsible for the collection and completion of his own players and their corresponding participant agreement and waiver forms. This includes, but is not limited to, having all players on your team complete their own individual waiver, keeping all waivers with you in a folder when playing on the sideline (preferably in a folder), and in the event of one of your own players no longer able to participate in that season, you can replace that team member with a new member, but are still responsible for having the new member complete a participant agreement and waiver form. **Walnut Creek Flag Football will assume no liability for team captains negligence in regards to waivers not completed or collected. This is the responsibility of the team captain.** This means that at any time a new player is added to your team, anytime between the beginning of the season through the championship, it is the team captains responsibility to keep all waiver forms up to date to participating players on his team.

### **Walnut Creek Flag Football Participant Agreement and Liability Release**

**RELEASE:** As a condition of and in consideration for the opportunity to participate in social and recreational sports activities (“Activities”) offered, organized, sponsored, and/or hosted by Walnut Creek Flag Football I, for myself and any of my heirs, personal representatives, executors, administrators, or assigns, do hereby release, discharge and covenant not to sue Walnut Creek Flag Football, its employees, principals, agents and volunteers from all liability and waive any claim for damages arising from any cause whatsoever.

**EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY:** In recognition of the risks inherent in the Activities in which I will engage, I confirm that I am physically and mentally capable of participating in those Activities and using any equipment that may be required in connection with those Activities. I am participating in the Activities willingly and voluntarily. I assume full responsibility for torn muscles, fractures, wounds, cuts, abrasions and/or contusions, head, neck, and/or spinal injuries, bites, attacks by animals or insects, allergic reactions, shock, paralysis, coma or death, and any expenses that are related to such injuries sustained by me. I also assume full responsibility for damage to or loss of my personal property that may occur during Walnut Creek Flag Football Activities or otherwise.

**INDEMNITY & HOLD HARMLESS AGREEMENT:** I agree that I will indemnify and hold harmless Walnut Creek Flag Football, its employees, principals, agents and volunteers from any loss or liability and waive any claim for damages or costs against them arising from any cause whatsoever related to my participation in Walnut Creek Flag Football Activities. I agree to indemnify and hold harmless Walnut Creek Flag Football with the knowledge that my agreement encompasses any and all claims arising from damages and/or injuries caused to me as well as any and all claims arising from damages and/or injuries caused by me.

**SCOPE OF PARTICIPANT AGREEMENT AND RELEASE:** I agree that this Participant Agreement and Release is intended to be as broad and inclusive as is permitted by the laws of the State of California. I further agree that, if any portion of this Agreement is held invalid, the remaining portions shall remain and continue in full force and effect. I understand that this is a full and final release applying to all unknown and unanticipated damages arising in connection with my participation in Walnut Creek Flag Football Activities, as well as to those now known or disclosed, and I waive all

rights and benefits that I now possess or in the future may acquired under the terms of Section 1542 of the Civil Code of the State of California, which provides: “A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor.”

**REGISTRATION RULES AND PLAYER CODE OF CONDUCT:** I hereby confirm that I have read the Player Conduct rules. I understand and agree to be bound by these rules. I understand that violation by me of Walnut Creek Flag Football’s registration rules will cause my team to forfeit all games in which I have participated. I also understand that any behavior on my part contrary to the Player Conduct or league rules may result in my dismissal from the event. By my signature below, I confirm that all registration information provided by me is true and correct.

**MEDICAL INSURANCE COVERAGE:** I understand that neither Walnut Creek Flag Football nor any of its employees, principals, agents or volunteers shall be required (1) to ensure that any participant’s health insurance coverage is valid and/or in force or (2) to confirm the validity of any participant’s personal identification. I further understand that it is my responsibility to maintain health insurance covering any injury that I may receive while traveling to, participating in, and/or returning from any Walnut Creek Flag Football Activities.

**EMERGENCY MEDICAL TREATMENT:** In the event of my injury in connection with any Walnut Creek Flag Football Activities, I consent to emergency medical treatment provided by a licensed physician, paramedic or other medical provider. Such care may be given under any conditions necessary to preserve my life, limb, and/or well being. I agree to hold all such medical providers rendering such emergency medical treatment harmless in connection with such efforts on my behalf.
